1 **JUDGMENT**

2 Pursuant to the Order Granting the Motion for Final Approval of the Class Action Settlement
3 and Motion for Attorneys’ Fees, Costs and Expenses, and a Class Representative Enhancement Payment
4 (“Order”), it is hereby **ORDERED, ADJUDGED, AND DECREED** as follows:

5 1. Judgment in this matter is entered in accordance with, and incorporates by reference the
6 findings of, the Court’s Order and the Joint Stipulation of Class and PAGA Action Settlement and
7 Release (“Settlement Agreement”). Unless otherwise provided herein, all capitalized terms used herein
8 shall have the same meaning as defined in the Settlement Agreement.

9 2. As provided by the Order, ~~all Class Members who did not timely and properly opt out~~
10 ~~from the Settlement are barred from pursuing, or seeking to reopen, any of the Class Member Released~~
11 ~~Claims, as defined by the Settlement Agreement. Moreover,~~ all Class Members, even if they opted out,
12 will release the PAGA portion of the Class Member Released Claims. Consistent with the definitions
13 provided in the Settlement Agreement, the Settlement Class consists of: Any non-exempt Teller, In-
14 Store Teller, Senior Teller, Lead Teller, Lead Teller Operations Specialist (“LTOS”), LTOS Trainee,
15 Associate Banker, Lead Associate Operations, Personal Banker, Private Client Banker, or Relationship
16 Banker position, or an equivalent position, in the State of California at any time between November 17,
17 2016 and August 1, 2019.

18 3. Without affecting the finality of the Judgment, the Court shall retain exclusive and
19 continuing jurisdiction over the above-captioned action and the parties, including all Class Members, for
20 purposes of enforcing the terms of the Judgment entered herein.

21 4. This document shall constitute a judgment (and separate document constituting said
22 judgment) for purposes of California Rules of Court, Rule 3.769(h).


